NEW BUSINESS

consideration, and on motion by Linda Bedwell and 2nd by Tony Richards,
Council voted by 4 ayes to table the matter until the July regular meeting.**

Council was asked to approve Resolution 2023-09 giving banking authority to new hire, Jessica Evans who is replacing Katie Elliott in the Clerk-Treasurer's office. Motion by Linda Bedwell, 2nd by Jeff Sparks. 4 ayes, passed.




Mayor Wilkes and the Council recognized Ron Lehman for his outstanding performance as Code Enforcement Officer.
